International students **must** be able to finance their own education since there is no financial aid available to them through the institution. Costs for the 2014-2015 academic year for international students are estimated at \$43,156, covering tuition, fees, room, board, books, medical insurance, and personal expenses. Students are responsible for proving their ability to meet these expenses. They are also responsible for budgeting for international travel and summer living expenses (not included in the cost estimate), for any unexpected increase in costs and for an increase each year for room, board, and out-of-state tuition.
