I also agree to indemnify and save harmless New College of Florida, the New College of Florida Board of Trustees, the State of Florida, the Florida Board of Governors and their respective officers, servants, agents, volunteers, or employees, from any and all liability arising out of, or in connection with, my acts while accompanying a Campus Police Officer on a tour of duty. I recognize that no employer-employee relationship is created during my observation, and that I will not be covered by the College's liability insurance or workers' compensation insurance. RULES AND PROCEDURES

The following rules and procedures are designated to guide and assist the petitioner, approved to accompany the New College of Florida Police during a tour of duty, as an observer.

The observer agrees to abide by all the following rules, regulations, restrictions and directives imposed by the New College of Florida Police Department, and the officer which he/she is assigned to accompany. Whatever the observer sees or hears of a confidential nature or that which is confided to me in my observer's capacity will be kept confidential until released by proper authority. I recognize to classify some happenings as confidential to protect and safeguard lives and to protect the innocent against deception. I accept this public trust and will strive to achieve these objectives.

The observer will not become involved in any part of an investigation. He or she will ride as an observer only. He or she will be asked to remain in the patrol vehicle on certain latent investigations. Under no circumstances will an observer be allowed to be armed or to operate any vehicle or police radio. The observer will not be allowed to be in the dispatch area or in the squad room without officer escort. He or she will be assigned to ride with an officer by the shift supervisor during any tour of duty. The officer or supervisor will terminate riding privileges immediately for any act of negligence, willful misconduct, or failure to obey any restriction, regulation or directive by the observer. The observer may terminate the tour of duty upon request at any time. The officer will notify the dispatcher of the observer's presence and when the observer ends the tour of duty.
