1	Resident Tuition (Matriculation)	\$105.07	54.7%	\$105.07	12.6%	\$398.13	83.9%	\$398.13	34.0%	The first three values comprise "tuition" in the traditional sense and are used to support the College's various Education & General expenses. At present, this revenue is used for faculty salary and benefits and student scholarships and financial aid. The Florida Legislature sets the "resident tuition" portion of tuition. The Board of Governors has decision authority to set the amount of "tuition differential" and "non-resident fee" upon request of the Board of Trustees. Current statutes limit the total aggregate increase in resident tuition plus differential to no more than 15% in any given year and the non-resident fee can't be increased more than 15% in any given year. At least 30% of revenue generated by tuition differential must be used for need based student financial aid.

At least 75% of the revenue generated by these fees must be used to support need based student financial aid.

6	Capital Improvement Fee	\$6.14	3.2%	\$6.14	0.7%	\$6.14	1.3%	\$6.14	0.5%	Revenue from this fee is collected by the College and remitted to Tallahassee for redistribution to the College for capital construction projects such as student activity centers, student recreation facilities and other student facilities not eligible for PECO funding. Timing of distributions vary depending on whether the revenues are bonded (favorability of bond markets and retirement of previous bond issues) or paid on a cash basis. Historically, the Legislature was solely responsible for setting this fee. Beginning with the 2012 fall semester, the Legislature authorized the Board of Trustees/Board of Governors some limited flexibility in establishing separate fee levels for each institution. The fee may not exceed 10% of resident tuition for Florida students or 10% of the sum of resident tuition and non resident fee for non Florida students and may not be increased more than \$2 per credit hour equivalent in any given year. Any increase or decrease in the fee must be recommended by the College's student fee committee whose composition is at least one student. The recommendations take effect only after approval by the College President, Board of Trustees and Board of Governors. During the past six fiscal years (13-14 to present), the Legislature and Governor have not approved any bonding. As a result, a smaller amount of these funds have been appropriated annually, and not held to support a b

The Health Fee supports student health (Counseling & Wellness) operations managed by Student Affairs. The Athletic fee supports specific campus recreation activities managed by Student Government. Any increase or decrease in these fees must be recommended by the College's student fee committee whose composition is at least one half students. The recommendations take effect only after approval by the College President, Board of Trustees and Board of Governors. The total of these three fees may not exceed 40% of resident tuition and the aggregate increase may not exceed more than 5% in any given year.

11	Green Fee	\$1.00	0.5%	\$1.00	0.1%	\$1.00	0.2%	\$1.00	0.1%	This fee was authorized by the Board of Trustees and Board of Governors (with the support of NCF Student Government) for use in supporting various campus sustainability initiatives as identified by Student Government. It took effect beginning with the 2012 fall semester. Any increase or decrease in the fee must be recommended by the College student fee committee whose composition is at least one half students. The recommendations take effect only after approval by the College President, Board of Trustees and Board of Governors.
